Patrolman's Update: The patrolmen have done some patching. They are fixing soft spots from the Spring. Burr Oak Road has a spot that has been patched three times. It will probably need to be redone – maybe have the County do a wedge. Some of the old road signs have been replaced. The new tractor should be here by the end of the month. There is a hole on Truman Road from a farmer coming out of the field onto the road. Mark contacted the farmer, and the Town will be billing for the repair.

Old Business:

Fire/Ambulance Reports- Belmont Fire District is still planning on having the Fireman's Dance. They are looking at Memorial Day Weekend, and are thinking of holding it outdoors.

Discussion on road maintenance projects for the year- The Town is looking at doing approximately 2 ¼ miles of additional seal coat besides Truman Road this summer. The roads to be

worked on are Oak Park Road, North Lane and Prairie Roads. Truman Road is being worked on with the LRIP project supplement funds. The Town may ask Scott's to see what they would charge to seal coat roads along Truman Road while they are there.

Update on the well agreement- All three parties have signed and notarized the agreement. This will be taken in and filed with the Register of Deeds at the Courthouse. The fee is \$30.00.

Board of Review is May 19th, 2021 from 11am to 1pm.

New Business:

Discussion on County Comprehensive Zoning Ordinance requirements- After some discussion, it was tabled on the County Ordinance.

Discussion on the American Rescue Plan Act (ARPA)- There is a local meeting on May 26th, 2021 in Darlington to give information on the ARPA.

Public Comment: None


Mark made a motion to adjourn. Seconded by Reggie. All Ayes. Meeting adjourned at 8:32 pm.


